TOWN OF BEVERLY: TO WIT

The regular monthly meeting of the Beverly Town Council was held Monday, May 13, 2019, at 6:30 pm in the council chambers of the Beverly Town Hall. The meeting was called to order by Mayor Cindy Karelis. Those present were Recorder Barbara Smith, council members Connie Pingley, Matt Lewis, Becky Weese, Rodney Cooper and David Harper, newly appointment replacement for Tena Pritt. Visitors included Debbie Stalnaker, Mark Scott, Chris Mielke, Barb McCreary, Phyllis Baxter, Cory Weese, Robbie Moyer, Andy Burns, Kenny Weese, Jarrod Phillips, Donnie Pritt, David Sturdivant, Robin Wilson, Eric Coberly, Katie Whittaker, Arden Swecker and Rhett Dugenbury.

Recorder Smith swore in David Harper, who will serve as council replacement for Tena Pritt thru June 2019.

Barbara McCreary from the Beverly Landmarks Commission reported that the Beverly Design Committee is meeting in the morning, May 14. She said some of the flowers that are seen throughout town are actually coming up from last year but more are being planted. She asked if anyone was interested in helping the committee with any of the projects to please contact them. She thanked the Town for having the Huttonsville inmates help with cleaning the town and Rich Mountain Battlefield. Mayor Karelis reminded Mrs. McCreary to turn receipts into the town for the committee's reimbursement.

Mark Scott wanted the Mayor and public to know he was not saying that the Mayor was changing the minutes when she edited Ms. Smith's minutes. At a previous meeting, Mr. Scott made reference to changes made to the minutes by Mayor Karelis. For clarification, Recorder Smith previously had Mayor Karelis review/proof minutes and include WV state codes where needed. Mr. Scott said it was not wrong for the Mayor to add information to the minutes as long as the additions or changes were made so noted in the minutes.

Eric Coberly from E.L. Robinson gave an update on the sewer project. The water flow has been monitored since November/December, lids have been pulled, and the pumping stations have been watched, especially the pumping station coming from Bruce Hardwood. There are issues with the Dodson Run man holes. He said that flow monitoring, more in-depth smoke detection; running cameras up the lines will give them better ideas of what to do. The next step is a study and report phrase and coming together with the town and Region VII. He said we need to see what we can take out before we know what we have to do. He feels the plant isn't big enough to handle the area Beverly has taken on since the plant was built. Most of last year's monthly gallons were 80% over what the DEP recommends.

Phyllis Baxter, Beverly Historic Landmarks Commission, presented the commission's yearly report. Her report included work done on the Randolph County Jail located on Walnut Street. She said terms for Linda Peterson and Janet Gould are expiring soon, but both women are interested in serving another term.

Chris Mielke, AmeriCorps, excited everyone with his report of a Saturday tour on History of the Women of Beverly. The tour will include Civil War romance, shocking case of liable in the courthouse and an interracial marriage. The town has three books that date back to the 1800's that were given to the town by John McGee. Two of the books show fine receipts of deceased local residents. Council shared their concerns about displaying those two books at the Heritage Center, but council agrees that all three books need to be preserved. The Mayor has several articles from the town that needs preserved. The town is interested in loaning or giving these to the Beverly Historic Preservation for safe keeping.

Troy Ware was not present for his informal presentation.

The Attorney General's office will be contacted in regards for payment to members of the Personnel Committee for attending meetings. Discussion was held on the issue of how many members should be on the committee and it was agreed to table the discussion until the new council was sworn in.

ARTIFACT DONATION/LENDING AGREEMENT - BHC

With concerns regarding environmental issues of the books donated by Mr. McGee and the other historical papers the town has, a motion was made by Mr. Lewis to give them to Historic Beverly Preservation for display with display exception of the two earlier discussed books that show personal names in them. Motion seconded by Mrs. Weese, all in favor.

AMENDED RESOLUTION SETTING FEE SCHEDULE FOR ACTIVITIES AND SERVICES PERFORMED FOR THE TOWN OF BEVERLY OR ITS AGENTS IN CARRYING OUT ITS RESPONSIBILITIES UNDER THE 2015 INTERNATIONAL PROPERTY MAINTENANCE CODE

WHEREAS, the Common Council of the Town of Beverly recently enacted an Ordinance adopting the 2015 version of the IPMC; and

WHEREAS, Section 103.5 of the State Building Code allows the Town of Beverly Council to set forth in a fee schedule "the fees for activities and services performed by Town of Beverly personnel or its agents in carrying out the responsibilities under this code" adopted by the Council by Resolution; and

WHEREAS, all information regarding such fees is made readily available to the public at the Town of Beverly Town Hall, 5 Walnut Avenue, Beverly, West Virginia; and

WHEREAS, the Common Council has determined that it is in the best interest of the citizens and residents of the Town of Beverly to list the following building code fees associated with its enforcement:

- (a) For New Construction and Additions, for Residential Renovation, Restoration, or Remodeling of Existing Structures, for Residential Porches, Decks, Garages and other Accessory Structures: Building Permit Fees up to \$1,000 = \$15.00; over \$1,000 = \$10.00 per \$1,000
- (b) For Commercial Construction, Additions and Accessory Structures: Building Permit Fees up to \$1,000 = \$15.00; over \$1,000 = \$10.00 per \$1,000
- (c) For Contractor's License: \$40.00 Flat Rate per job
- (d) For Business License: Minimum \$15.00 Maximum \$1,500, with variant amounts for different businesses totaled (ex. Restaurant = \$15.00 + Alcohol Sales \$150.00 = \$165.00)
- (e) For IPMC Violations not addressed within 20 Days of Notification: \$50.00 for the first day and \$50 for each additional day until rectified

NOW, THEREFORE, BE IT RESOLVED by the Town of Beverly Common Council, that, pursuant to the adoption of the 2015 International Property Maintenance Code by second and final reading on November 13, 2017, that the above fees represent a true and accurate rendering of those charged by the town.
