Status Water Plant Addition-The roofing is done the deck is half completed. Inside there is now heat upstairs, metal tank is done downstairs, trunk heat electrical has been started downstairs. Lights are mounted and wired in. Wire has been run to hook the cameras up. The cameras need to be updated let Andy know when they will be here for the cameras so he can meet with them The steps will be the last thing completed they were above and beyond the cost that was expected, Jim Bibey is making building them to code. A motion was made by Kenny Weese to allow \$9000.00 for the steps/deck to be moved to the regular account seconded by David Simmons. Motion carried. Some of the items purchased for the duct work have been returned.

You have to submit a confirmation to the state within 30 days of mailing out the letters to the customer's .Charleston said they had not received but, Cory had submitted the confirmation. He had to resend the information .The violation was dismissed.
