

The regular meeting of the Beverly Town Council was held Monday, December 9, 2019, at 6:30 pm in council chambers of Beverly Town Hall. Members and visitors stood for the Pledge of Allegiance and were led in prayer by council member Robbie Moyer. Mayor Andy Burns called the meeting to order in the presence of recorder Barbara Smith, members Debbie Stalnaker, Robbie Moyer, and Katie Whittaker. Matt Lewis and Becky Weese were absence. Visitors included Jarrod Phillips, Barbara McCreary and Chris Mielke.

Chris Mielke thanked council for all the help during the Old Fashion Christmas. He stated there were 236 visitors to the museum on Saturday and everyone had a delightful time. He thanked the members of council who put up the Christmas tree in the Town Square and said it was beautiful.

With all members having received copies of the minutes, Mrs. Stalnaker made a motion to forego the oral reading the November 4, 2019 minutes and to accept the minutes as submitted. Motion seconded by Mrs. Whittaker with all in favor.

OLD BUSINESS

The only old business discussed was the purchase of a dump truck and no decision was made at this time.

NEW BUSINESS

NAME CHANGE ON WATER CHECKING ACCOUNT

A motion was made by Mr. Moyers to remove David Sturdivant's name on the Water Checking account and all other water accounts; and to add Maynard K. Weese to the accounts. Motion seconded by Mrs. Whittaker to add Mr. Weese to the listed water accounts.

APPOINTMENT OF NEW IPMC PROBATIONARY INSPECTOR/CODE ENFORCEMENT OFFICIER

Mayor Burns informed council that Bill Annon will be leaving soon as the Building Inspector for the Town. Council discussed whether to just keep a building inspector, add a Code Enforcement Officer to the title, and/or hire a police officer. Mayor Burns will talk to other local mayors and get more information for our next meeting.

EMPLOYEE ONE TIME STIPEND

A motion was made by Mrs. Stalnaker to give employees a stipend of \$200.00 for full time and \$100.00 for part time after taxes and deductions on this month's paycheck. Mr. Moyer seconded the motion with all in favor.

DECORATIONS FOR TOWN SQUARE CHRISTMAS TREE

A motion was made by Mr. Moyer to reimburse Debbie Stalnaker \$110.96 for additional decorations for the Town Square Christmas tree. Motion seconded by Mrs. Whittaker. All in favor.

VENDOR INVOICES

A motion was made by Mrs. Whittaker to pay the December invoices in the amount of \$5822.72. Motion seconded by Mr. Moyer with all in favor.

UPDATES

E. L. Robinson is working on the manholes (between 400-500 on system). Hopefully in January, if weather permits, they can start running cameras in the lines.

Reed IPMC case has been discussed several times between the Mayor and our attorney.

Motion made to adjourn by Mr. Moyer and seconded by Mrs. Whittaker. Meeting adjourned at 7:50 pm.
