#### **New Business**

**Stenner Pump-** Does not have to be done now, but Cory would like to have a back-up pump for each pump. This pump can be used for any chemical. Will wait a couple of months before doing anything.

VFD # 2 at River- Is down and needs and needs repaired. Cory got an estimate from Extreme Endeavors to install a new VFD, the cost is \$3405.00. They also suggested when the new one is installed to add in the vents. Extreme Endeavors would install two vents in the VFD cabinet, one as air intake and one to push air out at a cost \$375.00. Kenny Weese made a motion to get a new VFD installed and include the vent installation . David Simmons seconded; motion carried AIF

Backwash VFD- A filter and fan has been replaced. The VFD has not been repaired.

Vacuum Trailer- This will be tabled until a later date.
