- 1. Monthly samples
- 2. Continuous water monitoring
- 3. Maintained plant cleaning and upkeep
- 4. Completed monthly reports
- 5. Mowed and trimmed grass
- 6. Jeremy sprayed CWF water sealer on wooden stairs
- 7. Replaced drive gears in (1) Stenner pump motor—saving approx.. \$300.00, these pumps were from Mill Creek and were 45M, we use 85M—this gear change converts them saving from purchasing a new pump
- 8. Rebuilt (3) Stenner pump heads--- saving approx.. \$500.00

9. Removed tool shadow board and electrical box that held the B/W pond decant pump switch and replaced with a smaller electrical box with switch and light, removed chemical storage cabinet from wall to be replaced by floor cabinets with wooden work tops

- 10. Cleaned out several areas of Water Plant and discarded items that were trash/junk and no longer used
- 11. Prepared Lead and Copper result letters for customers that participated in the sampling process—Mel is mailing them
- 12. Flushed off Sugar Creek tank (9/27/2022)
- 13. Patched holes in office walls to prepare for painting, painted walls
- 14. Fixed temperature gauge on generator and remounted into panel
- 15. Adjusted VFD drives on #1 and #2 high service pumps to create an even/constant flow through plant
- 16. Removed LED dusk to dawn light above the porch roof and relocated to the corner of the building (toward back gate)

- 17. Replaced a bad valve on raw water intake to prepare for polymer injection (replaced with a PVC valve—can not use metal/brass with chlorine and other chemicals)
- 18. Repaired 11/2 inch air line outside of building (this is the line that goes to river intake), ground settled and pulled line apart
