2023-13050— A sample for nitrate was required to be submitted within the first quarter of 2023 however the sample was not taken until April 12th of 2023. Results were reported May 1st 2023. The sample was within acceptable levels.

2023-12791— A sample for Volatile Organic Compounds was required to be submitted within the calendar year of 2022. The sample was taken on April 20th 2022 but was not submitted. The sample was within acceptable levels.

2023-12401/2022-12226/2023-12378/2022-12206— Required sampling for TTHMs and HAA5s were collected and submitted in the 1st and 3rd quarter as required, the samples were collected at the proper physical location however the address of the residence where they were collected was improperly reported. The sample was within acceptable levels.

2023-397498— Total Coliform samples require the Chlorine residual at the time of collection to be reported on the chain of custody that accompanies the sample to the lab. The chlorine residual was noted on the chain of custody but was not reported by the lab at the time of analysis and was later added. The sample showed absent for total coliform and e-coli.

2022-397494— The Operator whom submitted the turbidity report for the month failed to sign and date it. A sufficient number of readings were collected and were within acceptable levels.
