### **OLD BUSINESS**

- Celtic Festival & Highland Games will be on June 14<sup>th</sup> at the 4H Camp. They are seeking a donation from council again this year. Katie Whittaker moved and Kenny Weese 2<sup>nd</sup> to give them \$1,000. All in favor. Motion carried.
- 2. Beverly Elementary School playground donation is tabled until after the budget is set. Matt Lewis made a motion to have Ms. Ross come back and explain the funds needed again before deciding this year. Robbie Moyer 2<sup>nd</sup> the motion. All in favor. Motion carried.
- 3. Opioid Fund- Clerk Wilson gave a report on opening a checking account. Robbie Moyer made a motion to creating a checking account for the opioid funds. Katie Whittaker 2<sup>nd</sup> the motion. Motion carried.
- 4. Water & Sewer Boards Clerk Wilson showed a report on the past 2 years of bills paid by the town for the building, explaining that utilities have raised. - Good Friday- Matt Lewis made the motion to let the employees have Good Friday, March 29, 2024 off. Robbie Moyer 2<sup>nd</sup> the motion. All in favor. Motion carried.

6. Sidewalk and Bridge- the bridge railing on the sidewalk by Becky Weese's house has fallen and needs repaired. Matt Lewis made the motion to get it fixed as soon as possible. Robbie Moyer 2<sup>nd</sup> the motion. All in Favor. Motion carried.
