Fluoride Probe- This probe is needed to test our fluoride. We need to send a sample once a month to the state. The last several years our results have always been lower. Core & Main Maintenance Renewal- Kenny Weese made the motion to pay half of the \$3656.94 with Sewer paying half. David Simmons seconded; motion carried.AIF

Financial statements were reviewed.


Invoices


